### Preamble:

The Government of India in its letter read at (1) above has released an amount of Rs.500.00 lakhs for the year 2014-15 to the State Government for Implementation of the centrally sponsored scheme "Support to State extension programmes for extension reforms" and it has instructed the state to release matching 10% grant as state share for implementing the scheme (50% state share for Farmer Friend component).

The above grant released was not utilized as it was released during the end of financial year 2014-15. So, the Government of India has revalidated the grant and released it on 31-04-2015 mentioned in the letter read above (2).

The Finance Department, Government of Karnataka has confirmed the Central share grant of Rs.500.00 lakhs released under the said schemes through Credit Confirmation Slip dated 24-04-2015.

The Commissioner of Agriculture Bengaluru in his letter dated:27-04-2015 read at (3) above, has requested to release the sum of Rs. 555.55 lakhs towards central share of Rs.500.00 lakhs + 10% State share of Rs.55.55 lakhs under the Head of Account 2401-00-800-1-53 (059) Plan for the implementation of ATMA scheme during 2015-16.

In the Government order read at (4) dated 06-05-2015 approval is given to continue ongoing schemes, which includes ATMA Scheme for the year 2015-16.

The proposal of the department has been examined, Hence following is the order.

Government is pleased to accord sanction for the release of grant of Rs.555.55 lakhs (Rupees Five Hundred and Fifty Five lakh Fifty Five thousand only) under the head of account 2401-00-800-1-53 (059) (Plan) to Agricultural Technology Management Agency (ATMA) scheme. This includes the state share of Rs.55.55 lakh as 10% matching grant and also Rs.500.00 Lakh central grant allocated for General components.

The Commissioner for Agriculture shall implement the scheme strictly in accordance with the guidelines communicated by the Government of India. No deviation in any manner is permitted without approval of the competent authority in the Government.

Commissioner for Agriculture shall ensure that the monthly physical and financial progress report of the scheme is sent to the concerned Department/Division of Government of India within the prescribed schedule for their submission, under intimation to state Government.

The grant in aid bill submitted by Director of Agriculture for the ATMA scheme shall be countersigned by the Commissioner for Agriculture, Bengaluru.
